## REGISTERED ELECTRICAL MAINTENANCE TECHNICIAN

### CITY REQUIREMENTS

As per Chapter 10, all electrical maintenance work performed on a property requires an annual maintenance permit to be held. All work performed under the electrical maintenance permit must be performed by a Licensed Maintenance Electrician or by personnel whose competence has been certified by completion of a minimum 8-hour training course approved by the Electrical Examining and Supervisory Board.

*Electrical Maintenance* shall mean the replacement or repair of existing electrical appurtenances, apparatus, equipment, machinery, or controls used in connection with the use of electrical energy in, on, outside, or attached to a building, residence, structure, property, or premises. All replacements or repairs must be of the same rating and type as the existing installation. Electrical maintenance work does not include the installation of any new electrical appurtenances, apparatus, equipment, machinery, or controls beyond the scope of any existing electrical installation.

It is a violation of Chapter 10, Section 10-6 (c) (1) of the City Code to perform electrical maintenance work without a proper permit and current registered personnel.

NOTE: All persons performing electrical work under this section shall be licensed or registered as required by the City or State. All electrical work performed under this permit must be performed by master electricians, journeyman electricians, maintenance electricians, or electrical maintenance technicians.

Initial maintenance technician applicants must complete 8 hours of training approved by the code official.
